FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 14

The Board of Directors of Fort Bend County Levee Improvement District No. 14 will hold a regular meeting on **Monday, April 9, 2018, at 3:00 p.m.**, at One Avalon Place, Sugar Land, Texas, to discuss and, if appropriate, act upon the following items:

3. Financial and bookkeeping matters, including payment of bills, review of investments, and capital reserve.
4. Tax assessment and collection matters, including payment of tax bills, delinquent tax collections, and installment agreements.
5. Matters pertaining to the City of Sugar Land, including update regarding drainage study.
6. Sugar Land Ambassador Program - Brazos River Erosion Study.
7. Phase II MS4 Storm Water Management Plan implementation.
8. Levee maintenance.
9. Landscape upgrade and lighting around picnic area and boat dock at The Brazos Landing.
10. Engineering matters, including approve plans and specifications and authorize advertisement for bids for construction projects, review bids and award contracts, and approve pay estimates, change orders, and final acceptance as appropriate, for construction projects, including:
 - a. deeds, easements, or consents to encroachment;
 - b. trespassing of District Facilities by Fort Bend Independent School District and contractors for installation of fiber optic cable;
 - c. levee access crossing construction projects, including additional plantings;
 - d. discuss possible levee improvement projects;
 - e. Letter of Map Amendments;
 - f. Pump station design, installation, review of engineering report, design and specifications and cost estimate related to the same;
 - g. review updates to Emergency Action Plan; and
 - h. Reserve/Capital Improvement Project Spreadsheet.
11. Federal Emergency Management Agency applications for funding.
12. Operation of District facilities, including repairs and maintenance and authorize re-capping in Ponds A and B, as necessary and maintenance of lake edge and bulkhead, review proposals for repair of lower lakes bulkhead and authorize repairs, if appropriate.
13. Website at www.fblid14.org, including communication notices.

14. Perimeter levee inspection and meeting, levee and flood control conferences, common inspection and operation and maintenance, and joining Fort Bend Flood Management Association.
15. Discuss next regular meeting date and items for upcoming agenda.
