

## NOTICE OF MEETING

### FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 14

The Board of Directors of Fort Bend County Levee Improvement District No. 14 will hold a regular meeting on **Monday, August 13, 2018**, at **3:00 p.m.**, at One Avalon Place, Sugar Land, Texas, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments from the public.
3. Authorize attendance at 2019 National Association of Flood and Stormwater Management Agencies conference.
4. Financial and bookkeeping matters, including:
  - (a) payment of bills, review of investments, and capital reserve;
  - (b) amend budget for fiscal year end September 30, 2018; and
  - (c) discuss budget for fiscal year end September 30, 2019.
5. Tax assessment and collection matters, including payment of tax bills, delinquent tax collections, and installment agreements.
6. Discuss 2018 tax rate, set public hearing date and authorize notice of public hearing regarding adoption of tax rate.
7. Matters pertaining to the City of Sugar Land.
8. Phase II MS4 Storm Water Management Plan implementation.
9. Levee maintenance including expiration of Service Agreement proposal and budget from Champions Hydro-Lawn, Inc.
10. Landscape upgrade and lighting around picnic area and boat dock at The Brazos Landing.
11. Engineering matters, including approve plans and specifications and authorize advertisement for bids for construction projects, review bids and award contracts, and approve pay estimates, change orders, and final acceptance as appropriate, for construction projects, including:
  - a. deeds, easements, or consents to encroachment;
  - b. discuss possible levee improvement projects, including raising earthen levee and freeboard calculations;
  - c. Letter of Map Amendments;
  - d. Pump station design, installation, review of engineering report, design and specifications and cost estimate related to the same; and
  - e. Reserve/Capital Improvement Project Spreadsheet.
12. Review preliminary engineering report, cost estimates and financing for District projects and improvements and authorize engineer to proceed with necessary steps, including control staking, final design and construction phase services and project representative services.
13. Federal Emergency Management Agency applications for funding.
14. Operation of District facilities, including repairs and maintenance:

- a. authorize re-capping in Ponds A and B, and maintenance of lake edge and bulkhead, review proposals for repair of lower lakes bulkhead and authorize repairs, if appropriate; and
  - b. Brazos River erosion monitoring.

  16. Perimeter levee inspection and meeting, levee and flood control conferences, common inspection and operation and maintenance, and Fort Bend Flood Management Association matters.
  17. Discuss next regular meeting date and items for upcoming agenda.
  18. Consultant contract review and approve new or revised agreement, if appropriate.
