 - f. purchase and installation of Gator Pumps;
 - g. design and installation of sluice gates;
 - h. engineering design and construction proposals, including two dimensional dynamic analysis;
 - i. approve updated Emergency Action Plan; and
 - j. Homeowner Association land acquisition for Pump Station expansion.

 - a. update regarding re-capping in Ponds A and B;

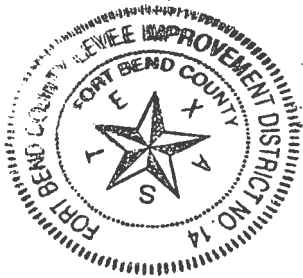
